



Conservation Cost-Share for Farmers and Ranchers

STATE PROGRAMS

The State of Florida has programs specially designed to help farmers and ranchers protect and improve the health of their land. These programs are administered through Florida Department of Agriculture and Consumer Services (FDACS) and Florida Department of Environmental Protection (FLDEP).

FDACS Agricultural Best Management Practices

FDACS Agricultural Best Management Practices program, often called the "Ag BMP" program assists producers in three ways:

- Provides a detailed manual of cost-effective actions to conserve water and reduce the amount of nutrients (fertilizers and animal waste) and other pollutants entering waterways. Each category of agriculture has its own industry-specific manual.
- Cost-shares this program helps farmers and ranchers
 with the cost of implementing these best practices.
 FDACS works with multiple partners, including the NRCS,
 FLDEP, water management districts, and soil and water
 conservation districts to provide cost share funding
 for producers.
- Implementing and maintaining FDACS-adopted BMPs provides a "presumption of compliance" with state water quality standards for the pollutants addressed by the BMP and may satisfy some water management district permitting requirements.

Additional benefits

Parts of Florida have highly environmentally sensitive waterways. In these highly sensitive parts of the state, the Florida Department of Environmental Protection (FDEP) is developing Basin Management Action Plans (BMAPs). These specialized plans help to meet adopted water quality targets. In BMAP areas that include agricultural land, producers must

Even in counties that do not have BMAP areas, large numbers of farmers and ranchers enroll in the FDACS Ag BMP program. For example, Sarasota County currently has no BMAP areas, but half of all agricultural land in the county is enrolled. Producers recognize that making equipment and systems upgrades to conserve water and decrease nutrient losses is good for their bottom line.

Interesting facts about FDACS Ag BMP program:

- Nearly 4 million acres of agricultural land is already enrolled in FDACS Ag BMP program. Florida is home to 9.7 million acres of agricultural land. That means that approximately two out of every five acres of agricultural land in Florida is enrolled.
- The top commodities enrolled in the program are cow/calf operations (1.5 million acres), row and field crops (1 million acres), and citrus (just under half a million acres)
